NOTICE IS HEREBY GIVEN that sealed bids will be received by the Shell Rock River Watershed District (SRRWD) until **4:00 p.m. CDT, March 9, 2018**, at the Shell Rock River Watershed District Office, 214 West Main St, Albert Lea, MN 56007, facsimile, or electronic transmissions will not be accepted. Bids will be publicly opened and read at said time and place by representatives of the SRRWD. Said proposals are for the furnishing of all labor and materials for the construction, complete in-place, for the Fountain Lake Restoration Confining Disposal Facility Construction. The Work shall include, but will not be limited to, the following:

- Installation of tile Line with 5 surface inlets;
- Stabilization of disturbed area;

No pre-bid meeting will be held for this project.

The Bids must be submitted on the Proposal Forms provided in accordance with the Contract Documents, Plans, and Specifications dated January 5, 2018 as prepared by WSB & Associates, Inc., which are on file with QuestCDN and may be seen at the office of the Consulting Engineer.

No bids will be considered unless sealed and timely filed with the Shell Rock River Watershed District and accompanied by a cash deposit, cashier's check, or certified check, or bid bond made payable to the SRRWD for five percent (5%) of the amount bid, to be forfeited as liquidated damages in the event that the bid be accepted and the bidder fail to enter promptly into a written contract and furnish the required bond.

The Owner reserves the right to reject any and all Bids, waive any informalities in bidding or to accept the Bid or Bids, deemed to be most favorable to the interest of the SRRWD. The Award is anticipated to be based on the lowest price, technically adaptable Bid.

All work required to be completed as part of this Project shall be completed by the following dates as outlined in the Contract Documents:

- The Work shall be substantially completed on or before July 1, 2018.
- The Work shall be completed and ready for final payment on or before July 1, 2018.

No Bids may be withdrawn for a period of sixty (60) days from the date of opening of Bids. The SRRWD reserves the right to reject any or all Bids.
