Bids for the construction of the Project will be received by ISG (the Engineer) electronically through QuestCDN until March 1, 2024 at 2:00 PM local time. At that time the Bids received will be posted publicly online.

The project includes the following major quantities of Work:

1. 8 Rock Reefs consisting of 2,962 cubic yards of MNDOT Class II Riprap and 2,16 cubic yards of #2 washed stone
2. Bid Alternate for 12 Brush Reef Crib assemblies
3. 57 boulder clusters consisting of MNDOT Class IV and Class V Riprap with Bid Alternate for 10 additional boulder clusters
4. Erosion control and site restoration
